Saturday, January 31, 2026

- 30th Anniversary \$30,000 Giveaway event day is Saturday, January 31, 2026.

- 1 earned entry equals 200 base points in slot play or 1000 base points in table play.

How Winners are Selected and Announced:

- At each drawing time, winners are drawn at random by PKMS computer programming based on all entrants who meet eligibility.
- Winners are announced over the casino PA System and posted on various monitors on property.
- Guests may only win once between 6 and 9:40 pm but may also win at 10 pm.

- Any employee of Rising Star Casino Resort (RSC) and Gaming Entertainment (Indiana) LLC, which is a wholly owned subsidiary of Full House Resorts, Inc, employees of participating vendors, plus any IGC employee/agent/commissioner and/or spouse may not participate.
- Immediate family members (which include spouse, mother, father, brother, sister, or children plus mother-in-law or father-in-law) of any Level 1 or promotion-related Level 2 occupational licensees (promotion-related Level 2 occupational licensee means the immediate family member is employed in one of the following departments: Information Technology, Marketing, Promotions Administration, Surveillance, or any other department that the Commission determines may affect the outcome of a promotional event) are not eligible to win a promotional prize valued at \$1,000 or more.
- A guest on the State Voluntary Exclusion Program (VEP), State Involuntary Exclusion List or evicted from RSC property is not eligible.

CARD SHARKS DINNER GAME SHOWS

Saturday, January 17, 2026

Eligibility:

- Must be 21 or older and an invited Rising Star VIP Club Member (VIP Club/Card/Member/Account).
- Any employee of Rising Star Casino Resort (RSC) and Gaming Entertainment (Indiana) LLC, which is a wholly owned subsidiary of Full House Resorts, Inc, employees of participating vendors, plus any IGC employee/agent/commissioner and/or spouse may not participate.
- Immediate family members (which include spouse, mother, father, brother, sister, or children plus mother-in-law or father-in-law) of any Level 1 or promotion-related Level 2 occupational licensees (promotion-related Level 2 occupational licensee means the immediate family member is employed in one of the following departments: Information Technology, Marketing, Promotions Administration, Surveillance, or any other department that the Commission determines may affect the outcome of a promotional event) are not eligible to win a promotional prize valued at \$1,000 or more.
- A guest on the State Voluntary Exclusion Program (VEP), State Involuntary Exclusion List or evicted from RSC property is not eligible.

How to Accumulate Entries:

- Each invited VIP Member receives two drawing tickets when checking-in for the Card Sharks Game Shows (show/s) in the Pavilion from 4 pm to 5:20 pm for Show 1 and 4 pm to 7:20 pm for Show 2 on Saturday, January 17, 2026 (event day).
- The invited VIP Member may use both tickets or offer one ticket to their guest if also a VIP Member.
- Tickets must have the VIP Member's full name and Player ID number clearly printed. Illegible and/or incomplete information voids the ticket and a replacement is drawn.

How to Activate Entries and Participate:

- Tickets must be deposited in the Grand Theatre ticket drum between 5 and 5:30 pm for Show 1 or between 7 and 7:30 pm for Show 2 (seating times).
- At the end of each seating time (5:30 and 7:30 pm), the ticket drum is taken to the stage and 10 names are drawn for the following prizes: (5) Card Sharks game plays and (5) \$50 FSP prizes. Alternates are drawn but not announced unless needed. There are no duplicate winners. RSC may elect to add more winners to Play Card Sharks and/or \$50 prizes. Card Shark plays are drawn before \$50 prizes.
- Each name is announced in the theatre a maximum of three times over 30 seconds. Guests must be in the theatre when announced and make their presence known (stand/wave/shout) then come to the stage. RSC reserves the right to extend the acknowledgement time if necessary.

- Prior to playing, each winner has the option to "cut" a standard 52-card deck of oversized novelty cards, face down, up to three times. Before each seating time, the cards for each game are thoroughly washed and shuffled.

- Once cut or the cut option has been declined, the winner has the option for the emcee to deal the first 7 cards off the top OR every other card OR every third card. The options to cut and the choice on how to deal are to make the deck as random as possible.
- The first card is turned face up and the winner is instructed to guess whether the next card face down is higher or lower than the card just revealed. In this game, Aces have the highest value followed by Kings, Queens, Jacks and then all numerical cards in order from 10 down to 2.
- If the guess is correct (and for each successful guess which follows up through the seventh and final card), the winner has the option to "freeze" and keep the amount of FSP shown on the board above the card just revealed or discard that amount and try to guess the next high/low card for a bigger prize.
- Any incorrect guess results in the winner receiving the base prize of \$100 FSP.
- In the event the newly revealed card ties the value of the previous card, a replacement card off the top of the deck is placed face down over the newly revealed card and the winner guesses again. The winner may change their prior guess.
- With each correct pick, the FSP prize value goes up. Prizes are not cumulative.
 - Card 1- \$100 (base prize). Guess next card high/low correctly to win...
 - Card 2- \$150. Guess next card high/low correctly to win...
 - Card 3- \$200. Guess next card high/low correctly to win...
 - Card 4- \$400. Guess next card high/low correctly to win...
 - Card 5- \$600. Guess next card high/low correctly to win...
 - Card 6- \$800. Guess next card high/low correctly to win...
 - Card 7- \$1000. Maximum prize.
- Card Sharks participants get to keep the oversized deck of novelty cards they played the game with.
- After each dinner seating, the drawing drum is cleared in preparation of the next seating time.

How to Claim Prizes:

- All winners go to the prize table on stage to confirm their winnings and fill out a winner's log. A VIP Card and valid photo ID are required.
- Winners of prizes valued at \$1000 or more must sign a Family Member Disclaimer (FMD) prior to receiving their prize. If there is uncertainty whether the winner has an immediate family member employed by RSC, the name of the RSC employee must be provided. A determination is made within (7) seven days if the winner can claim their prize. Should the winner be disqualified under the FMD, the prize is voided and not redrawn.
