# 18-HOLE TEAM SCRAMBLE:

- The scramble on Saturday, September 20, 2025 follows a light breakfast on The Links Patio (apx 9 am).
   Teams head to their assigned starting holes for a shotgun start at 10 am.
- Please maintain a good pace of play.
- **Format:** Each team has 4 players. Subs are available to help complete a team; however, it is possible some teams may have an odd number of players.
  - Per hole, each player of each team hits a shot from the tee. The best shot for their team is used for the next shot. The process continues in the same manner until the ball is holed out and one team score for the hole is recorded. Two putt max once on the green.
  - Prior to the green, the ball may be moved one club length to a like condition (e.g. ball in the rough must be played in the rough) but no closer to the hole.
- Should a player drop out of the scramble, remaining players may NOT hit alternating shots for the missing player.
- There is a two-putt max per hole. If all team members fail to make their first putt, add one additional stroke to the score and move on to the next hole.
- Tees: Ladies plus Men 75 and older/Red. Men 65-74/White. Men under 65/Blue.
- Waste Bunkers: clubs may be grounded in the large bunkers adjacent to the fairways.
  - Clubs may not be grounded in greenside bunkers.
- Lateral Water Hazards: marked by red lines or red stakes.
- Out of Bounds: marked by white lines or white stakes.
- Black and White Fairway Poles: indicates 150 yards to the middle of the green.

- Cart Rules: may be driven on the cart path or on the fairway unless there is a full restriction to cart path only (to be determined at start time). Carts are to remain out of the rough.
  - o On Par 4s and 5s, carts must stay behind cart signs in front of the greens.
  - o On Par 3s, carts should remain on the cart paths.

# PROXIMITY PRIZES (announced during Awards Ceremony):

- A \$100 Links Pro Shop Gift Card is awarded to the player for:
  - o Closest To The Pin on holes 4, 9 and 13. (No proximity prize on Hole 6 due to special game.)

  - If the team scramble is started but not completed for any reason, proximity prizes are still awarded based on the results when play is stopped.

# **NEW! HOLES WITH SPECIAL GAMES:**

- Par 3/Hole #6: There are two circles on the green. A player who hits a tee shot that settles within the outer circle wins \$25 free slot play (FSP) or \$50 FSP if it settles within the inner circle.
- Par 5/Hole #3: All team members are dealt a hand of blackjack. If any player on the team is dealt a blackjack (not hit to reach 21), all team members hit from Hole 3's closest tee box.
- Par 5/Hole #12: All team members roll two oversized dice, one player at a time, from a designated spot on the tee box. The dice must fully cross the line and tumble (not slide or scoot). If a 7 is rolled, all team members must hit from Hole 12's furthest tee box. If a 2 or 12 are rolled, all team members must hit from Hole 12's closest tee box. Note: the last roll of consequence (7, 2 or 12) determines tee box location.
- All 3 special games' holes are administrated and monitored by RSC staff. RSC staff will also record FSP information on a winner's log where applicable.

#### AWARDS DINNER:

- Following the team scramble, the Awards Dinner is held in the Grand Theatre (apx. 3 pm based on weather and pace of play). The event includes dinner and complimentary cocktails for the player and guest thereof. Awards will begin approximately 30 minutes after doors open for dinner.
- All participants in the golf tournament and guests thereof receive a wristband for the Awards Dinner and drinks at any Casino Bar until 6 pm. The golf participant also receives 1drawing ticket.
